The undersigned nursing organizations respectfully request that during the negotiations of the American Recovery and Reinvestment Act, the \$600 million House provision for nursing and health professions training be included in the final stimulus package passed by both the House and Senate. A significant portion of this funding would be dedicated to filling the nation's current need for well over 140,000 registered nursing positions by providing a much needed increase in funding for the Title VIII Nursing Workforce Development Programs administered by HRSA/HHS.

At a time when millions of Americans are unemployed, good paying registered nursing jobs are going unfilled in our hospitals, nursing homes, health departments, and community health centers. Nursing positions are in great demand as there is currently an 8.1% vacancy rate across the country according to American Hospital Association. Funding for nurse training will lead to real jobs because a very real need exists. The demand for nursing jobs can only be met with nurses graduating from these training programs. Funding for nurse training will meaningfully contribute to the reduction of the unemployment rate.

Moreover, the *New York Times* recently reported on the Japanese experience with a stimulus plan. It was noted that "spending in knowledge-based services like health care and education" brings larger benefits to advanced economies like Japan's and ours by inference. The article further noted that the return on financing for education through a stimulus package was almost 25% greater than other forms of spending. Investing in nurse training will yield a greater economic return.

Maintaining the House's level of support for nurse training would pave the way to fill thousands of job openings within the next 1-3 years and strengthen the healthcare workforce, which is necessary to improve access and quality while lowering costs.
