### Overview

Learning any new medical technology requires both guided and self-directed learning on the part of the physician and team. The following document outlines recommended activities for the OR/support staff who seek to develop the knowledge and skills necessary to support Intuitive technology. ### PHASE I - Introduction to da Vinci Technology
