ELECTION STATEMENT

In my over 30 years in health care, I have always considered myself an OR nurse first. As I have continued my journey into leadership I maintain a keen focus on the voice of the perioperative nurse at the bedside. As a health care leader, I never want to lose that focus and that is why I took a PRN position in an orthopedic ambulatory surgical center on weekends to maintain my bedside knowledge and keep a sense of best practice in the OR setting.
