# **ELECTION STATEMENT**

At the height of the pandemic, I co-led 77 Illinois perioperative nurses, as we turned advocacy into action. Within months, we passed one of the fastest surgical smoke plume evacuation laws in the country and ensured regulatory oversight. That experience grounded my belief that perioperative nurses belong at the table as leaders who drive safer practice and lasting policy.

I bring four years of continuous Board service and a leadership record rooted in transparency, operational rigor, and strategic growth. When AORN selected a new Executive Director in 2024–2025, I supported governance continuity and helped initiate a turnaround plan. I also backed a member dues reduction strategy grounded in data and feedback.

In parallel, I've grown *The Stitch*, AORN's digital platform for novice perioperative nurses. We published 151 evidence-based articles and mentored 40 first-time contributors, many of them chapter leaders. It became a model for how inclusive publishing drives engagement and keeps members connected to the mission.

When members see their fingerprints on outcomes, they stay. As Secretary, I'll ensure AORN's records reflect your values, decisions follow data and the members remain central to national strategy. I'll champion tools and communication strategies that help members shape national priorities and feel their voices reflected in Board action. I know the role. I've lived the responsibility, and I'm committed to carrying it forward with clarity and collaboration.
